

SPECIFIC PROMOTION TERMS AND CONDITIONS

FOR GOLDEN WEEK CASHBACK PROMOTION

The Golden Week Cashback Promotion (the **promotion**) is provided by Titan FX Limited and Titan Markets, trading under Titan FX, to its clients. By participating in this promotion, the clients hereby acknowledge, confirm and accept to be bound by the following terms and by Titan FX Limited's Terms and Conditions and Titan Markets Terms and Conditions.

Promotion overview

This promotion is open to all eligible clients to receive a fixed per lot cashback amount for eligible FX and Gold trades during the promotion period of 2023 April 17th 00:00 to May 5th 23:55 GMT+3.

1. Qualifications

- 1.1. The client must register for the promotion in their Client Cabinet and select one of their accounts as the Main cashback account. The selection cannot be changed during the promotion.
- 1.2. The client must meet qualification requirements (see table below) during the promotion to be eligible to receive the cashback.

Tier qualification (Deposit) requirements in account currency

- 1.3. The qualifying deposits can be made into different accounts belonging to the same client. If those accounts have different account currency, the deposit amounts are converted to main cashback account currency using the current exchange rate and summed up.
- 1.4. If the client completes the qualifying deposit by making several deposits, the client becomes eligible for cashback only when the full deposit requirement amount is met. For example, if the client deposits 100 USD on April 17th and 300 USD on April 20th, he is eligible to receive cashback after the second deposit is made on April 20th.

2. Cashback calculation

- 2.1. Cashback amount is calculated by multiplying the number of lots by cashback amount per lot (see table below) in Main cashback account currency. Cashback will not be received if total eligible trade volume during promotion period is below 1 lot.

Cashback amount per lot in account currency

- 2.2. Cashback amount will be increased for eligible gold trades that are opened and closed during the last week of the promotion (2023 May 1st 01:00 GMT+3 - May 5th 23:55 GMT+3) - see table below. Cashback amount remains the same for FX trades throughout the promotion period and gold trades that have been opened before the last week of the promotion.

Increased cashback amount per GOLD lot in account currency during May
1st 01:00 - May 5th 23:55 GMT+3

- 2.3. The client receives cashback based on the Tier their current net deposit qualifies them for. Withdrawals in excess of earned profit might decrease the Tier (refer to section 4.2 below)..
- 2.4. If a client's Tier changed while a trade was open, the cashback is calculated using the Tier active at the time of trade closing. For example, if a client qualifies for Tier 1, opens a trade, qualifies for Tier 2, closes the trade, then they receive Tier 2 cashback for that Tier.
- 2.5. The cashback is calculated in the currency of the Main cashback account and deposited into this account at least once a week.

3. Trade and account eligibility

- 3.1. This promotion is only valid for verified live Titan FX Standard and Blade trading accounts.
- 3.2. Only trades that have been both opened and closed in the promotion window are eligible trades.
- 3.3. This promotion is applicable to all FX and gold instruments tradeable in Standard and Blade accounts only.

4. Fraudulent activity and withdrawal

4.1. Titan FX at its sole discretion can exclude a client from participating in this promotion:

4.1.1. if a client is suspected of fraudulent activity

4.1.2. and/or a client has not acted in good faith

4.1.3. and/or an action by a client is found to be in violation of these terms and/or Titan FX's Terms and Conditions.

4.1.4. and/or a client submits false ID documents for the verification procedure.

4.2. Withdrawals during the promotion may affect promotion qualification:

4.2.1. The client is able to withdraw trading profit earned from trades that were opened after they registered for the promotion and closed before the end of the promotion without decreasing their qualifying deposit if the withdrawal is only for the trading profit.

4.2.2. If the client withdraws more than their trading profit or a portion or all of their qualifying deposit at any time during the promotion window, this may decrease their qualifying deposit amount which may result in decreasing their tier or may also affect their eligibility for this promotion.

5. General conditions

5.1. Titan FX reserves the right to refuse offering this promotion at its sole discretion without prior notification or justification.

5.2. New accounts are subject to approval as per Titan FX's procedures. This promotion is not an offer to any person to whom it would not be lawful.

- 5.3. The clients participating in this promotion are able to participate in other promotions run by Titan FX if they meet the requirements for those promotions.
- 5.4. Titan FX reserves the right to alter, update or cancel this promotion at any time. Titan FX will notify participants as soon as possible. Titan FX will not be liable for any consequences resulting from the alteration, update or cancellation of this promotion.
- 5.5. This promotion shall not encourage clients to trade in a manner inconsistent with their trading comfort level. Clients should seek independent advice if necessary.
- 5.6. Titan FX will not be liable for any loss, costs, expense or damage suffered in connection with this promotion.
- 5.7. Any dispute will be resolved by Titan FX in a fair manner.
- 5.8. If those terms are translated in another language than English, the English version of these terms shall prevail in case of inconsistency.
