Exclusive Singles' Day promo code offer (the **"Promotion"**) is provided by Titan FX Limited, Titan Markets and Goliath Trading Limited, trading under Titan FX, (Titan FX) to their clients. By participating in this Promotion, the clients hereby acknowledge, confirm and accept to be bound by the following terms and by [Titan FX's Terms and Conditions](#).

Promotion overview

This Promotion offers eligible clients the chance to redeem a promotional code and receive 25 USD Welcome Bonus from November 11th 00:00 GMT+2 to November 17th 23:59 GMT+2 (the **"Promotion Period"**).

1. Specific Offer terms

- 1.1. Clients who redeem the promotional code **SINGLES24** (the **"Promo Code"**) will receive a 25 USD Welcome Bonus (the **"Bonus"**) in their trading account.
