

## SPECIFIC PROMOTION TERMS AND CONDITIONS FOR TITAN FX GOLDEN WEEK 2025 PROMOTION

The Golden Week 2025 Promotion (the "**Promotion**") is provided by Titan FX Limited, Titan Markets, Goliath Trading Limited and Atlantic Markets trading under Titan FX, to their clients. By participating in this Promotion, the clients hereby acknowledge, confirm and accept to be bound by the following terms and by [Titan FX Limited's Terms and Conditions](#).

### Promotion overview

This Promotion offers eligible clients the chance to receive a fixed per lot cashback amount for eligible Gold trades, along with the Golden Week Prize, from April 28th, 2025, 00:00 (GMT+3) to May 11th, 2025, 23:59 (GMT+3) (the "**Promotion Period**").

#### 1. Registration and eligibility criteria

- 1.1. Clients must register for the Promotion in their Client Cabinet and select their main Promotion account. Registrations for the Promotion will open on April 14th, 2025, at 00:00 (GMT+3) and will remain open until May 11th, 2025, at 23:59 (GMT+3) (the "**Registration Period**").
- 1.2. Clients must meet the minimum net deposit requirements to be eligible for cashback (see table below):

#### ***Minimum net deposit requirements in account currency***

- 1.3. Additionally, to be eligible to receive the Golden Week Prize, clients must meet the following cumulative criteria:
  - 1.3.1. Make a minimum net deposit of at least 10,000 USD (or 1,500,000JPY / 9,640EUR / 13,540 SGD equivalent); and
  - 1.3.2. Complete a minimum of 50 lots traded in Gold instruments in SD/BD accounts, or 500 lots in Micro accounts.
- 1.4. Clients can receive both the cashback and the Golden Week Prize (the “prize”) upon meeting the minimum net deposit requirements under 1.2. and 1.3 respectively.
- 1.5. The Clients who will meet the criteria above for the Golden Week Prize, will be contacted via their email addresses used at the time of registration (the Notification Email). The Clients must confirm acceptance of the prize within 30 days from the Notification Email.
- 1.6. If Titan FX is unable to contact the client due to inaccurate contact details provided, and the client does not contact Titan FX within thirty (30) days from the Notification Email to claim the prize, the prize will be voided without any liability on Titan FX. It is the client’s sole responsibility to ensure that accurate contact details are provided.
- 1.7. Titan FX does not provide invoices and/or warranty certificates for the prizes.
- 1.8. If the client wants to change his or her delivery address, he or she must do so when accepting the prize. The delivery address must be in the name of the client. It is the client’s responsibility to ensure that an accurate delivery address is provided. The client cannot change the delivery address once the

prize has been accepted.

- 1.9. Delivery of the prize may not be available in certain countries. Titan FX can decide, at its own discretion, to send cash prizes instead. The value of the cash prize will be similar or less to the prize that the Client wins.
- 1.10. The delivery of the prize will be done by a courier. If the client is absent during delivery, the courier will handle re-delivery. The client shall contact the courier to ensure delivery of the prize.
- 1.11. Titan FX will not be responsible or liable for any delay or non-delivery of the prize(s) and any loss, costs, expense or damage suffered by the clients as a result of the delay or non-delivery.

## **2. General net deposit requirements for Cashback and Golden Week Prize**

- 2.1. The client's net deposits are the sum of all deposits minus all withdrawals in all their accounts between registering for the Promotion and at the end of the Promotion Period.
- 2.2. Net deposits are calculated in the currency of the client's chosen main Promotion account. If the client makes deposits or withdrawals into/from other accounts that have a different account currency, the current exchange rate (i.e. daily FX rate available to Titan FX) is used to convert the deposit or withdrawal into the Promotion account currency.
- 2.3. Withdrawals of only trading profit earned from trades that were opened after the client registered for the Promotion and closed before the end of the Promotion Period will not be subtracted from the net deposit.

- 2.4. If the client withdraws more than their trading profit or a portion or all of their deposited amount at any time during the Promotion Period, this may decrease their net deposit amount which may result in the participant being ineligible to participate further in the Promotion.

### 3. Cashback calculation

- 3.1. Only trades made within the Promotion Period are eligible for cashback.
- 3.2. Cashback amount is calculated by multiplying the number of qualifying lots by cashback amount per lot (see table below).

- 3.3. The amount of traded lots is summed up across trades (e.g. if a client opens a 1.5 lot trade, and a 0.5 lot trade, the cashback will be calculated for two (2) lots).
- 3.4. The amount of traded lots of different eligible instruments is summed up (e.g. if a client traded 1.5 lots XAUUSD and 0.5 lots XAUEUR, the cashback will be calculated for 2 lots).
- 3.5. Clients will receive cashback based on the Tier their current net deposit qualifies them for. Withdrawals in excess of earned profit may result in a Tier downgrade.
- 3.6. The cashback will be calculated in the currency of the Client's chosen Promotion account and deposited into the same account twice a week.

#### **4. Trade and account eligibility**

- 4.1. This Promotion is applicable to all live Titan FX accounts.
- 4.2. Both new and existing clients are eligible to participate.
- 4.3. This Promotion is applicable only to Gold instruments (XAUAUD, XAUCHF, XAUEUR, XAUGBP, XAUJPY, XAUUSD, XAUUSD-m).
- 4.4. Only trades that are open for more than two (2) minutes will be eligible to receive cashback or/and the Golden Week Prize.
- 4.5. Only trades that have been opened in the Promotion Period are eligible trades.

#### **5. Fraudulent activity**

- 5.1. Titan FX at its sole discretion can exclude a client from participating in this Promotion:
  - 5.1.1. if a client is suspected of fraudulent activity; and/or
  - 5.1.2. and/or a client has not acted in good faith; and/or

- 5.1.3. and/or an action by a client is found to be in violation of these terms or Titan FX's Terms and Conditions ; and/or
  - 5.1.4. if a client submits false ID documents and phone number for the verification procedure.
- 5.2. Titan FX reserves the right to withhold or void without further notice the prize amounts, or/and restrict or terminate the client's trading account, if in its reasonable belief, there is any indication or suspicion of any form of arbitrage (including but not limited to risk free profiting), abuse, fraud, manipulation, cash-back arbitrage connected to a trading bonus or any other form(s) of deceitful or fraudulent activity or behaviour (artificial trading activity, false identity or misrepresentation, collusion or coordinated trading, multiple accounts registrations under the same individual or associated parties to gain an unfair advantage).

## **6. General conditions and warranties**

- 6.1. In participating in this Promotion, the client agrees to be bound by these terms and Titan FX's Terms and Conditions.
- 6.2. The client agrees that Titan FX has the right to alter, update or cancel this Promotion at any time without any prior notice or justification to the client.
- 6.3. The client agrees that Titan FX will not be held responsible for any consequences resulting from any alteration, update or cancellation of this Promotion.
- 6.4. Titan FX reserves the right to refuse offering this Promotion at its sole discretion without prior notification or justification.
- 6.5. Titan FX will not be liable for any adverse effects where an account has open positions or floating profit/loss which results in the Promotion being removed for any reason.

- 6.6. New accounts are subject to approval as per Titan FX's Terms and Conditions. This Promotion is not an offer to any person to whom it would not be lawful.
- 6.7. This Promotion shall not encourage clients to trade in a manner inconsistent with their trading comfort level. Clients should seek independent advice if necessary.
- 6.8. By participating in this Promotion, you consent to your personal data being collected, processed, and used by Titan FX for marketing and promotional purposes.
- 6.9. Titan FX will not be liable for any loss, costs, expense or damage suffered in connection with this Promotion.
- 6.10. Any dispute will be resolved by Titan FX in a fair manner.
- 6.11. If these terms are translated in another language other than English, the English version of these terms is the official version and shall prevail in case of inconsistency.
