



SPECIFIC PROMOTION TERMS AND CONDITIONS

FOR EXCLUSIVE NEW PRODUCT LAUNCH 2024 PROMO CODE OFFER

Exclusive New Product Launch 2024 promo code offer (the **"Promotion"**) is provided by Titan FX Limited, Titan Markets, Goliath Trading Limited and Atlantic Markets Limited, trading under Titan FX, (Titan FX) to their clients. By participating in this Promotion, the clients hereby acknowledge, confirm and accept to be bound by the following terms and by Titan FX's Terms and Conditions.

Promotion overview

This Promotion offers eligible clients the chance to redeem a promotional code and receive a fixed cashback of 2 USD for every 100,000 USD in traded value on eligible asset class trades from December 16th 00:00 GMT+2 to December 20th 23:59 GMT+2 (the **"Promotion Period"**).

1. Specific Offer terms

- 1.1. Clients who redeem the promotional code **INDEX24** (the "Promo Code") and make a net deposit of a minimum of 200 USD (or equivalent 30,000 JPY / 190 EUR / 270 SGD) will receive a fixed cashback of 2 USD (or equivalent 300 JPY / 1.9 EUR / 2.7 SGD) for every 100,000 USD value traded on eligible asset classes.
- 1.2. Clients must redeem the Promo Code before the end of the Promotion Period. The Promo Code can be redeemed by logging into the Client Cabinet and entering the Promo Code in the redemption bar.
- 1.1. The cashback will be credited to the account used by the client to redeem the Promo Code after the end of the Promotion Period.

2. Eligibility conditions

- 2.1. This Promotion is applicable only to eligible asset classes such as Index, Soft commodity and Energy instruments.
- 2.2. This Promotion is applicable to all live Titan FX accounts (new and existing ones).

3. Net deposit requirements:

- 3.1. Clients' net deposit is the total amount of deposits minus the total amount of withdrawals across all their accounts, for the whole Promotion Period calculated by Titan FX at the end of the Promotion Period.
- 3.2. Net deposit is calculated in the currency of the client's selected Promotion account. If the client makes deposits into or withdrawals from other accounts with different currencies, the current exchange rate will be used to convert the deposits or withdrawals into the Promotion account currency.
- 3.3. Withdrawals of only trading profit earned from trades that were opened after the client registered for the Promotion and closed before the end of the Promotion Period will not be subtracted from the net deposit.
- 3.4. If the client withdraws more than their trading profit or a portion or all of their deposited amount at any time during the Promotion Period, this may decrease their net deposit amount which may result in the client being ineligible to participate further in the Promotion.

4. Traded value requirements

- 4.1. Clients must trade a minimum of 100,000 USD in Index, Soft commodity or Energy instruments during the Promotion Period to be eligible to receive cashback.
- 4.2. Traded value is the total amount of value traded across all trades in any of the client's accounts that were opened after the client redeemed the Promo Code until the end of the Promotion Period.
- 4.3. Only trades that are open for more than 2 minutes are eligible trades.

5. Fraudulent activity

- 5.1. Titan FX at its sole discretion can exclude a client from participating in this Promotion:
 - 5.1.1. if a client is suspected of fraudulent activity; and/or
 - 5.1.2. and/or a client has not acted in good faith; and/or
 - 5.1.3. and/or an action by a client is found to be in violation of these terms or Titan FX's Terms and Conditions ; and/or
 - 5.1.4. if a client submits false ID documents and phone number for the verification procedure.

6. General conditions

- 6.1. In participating in this Promotion, the client agrees to be bound by these terms and Titan FX's Terms and Conditions.
- 6.2. The client agrees that Titan FX has the right to alter, update or cancel this Promotion at any time without any prior notice or justification to the client.
- 6.3. The client agrees that Titan FX will not be held responsible for any consequences resulting from any alteration, update or cancellation of this Promotion.

- 6.4. Titan FX reserves the right to refuse offering this Promotion at its sole discretion without prior notification or justification.
- 6.5. Titan FX will not be liable for any adverse effects where an account has open positions or floating profit/loss which results in the Promotion being removed for any reason.
- 6.6. New accounts are subject to approval as per Titan FX's Terms and Conditions. This Promotion is not an offer to any person to whom it would not be lawful.
- 6.7. This Promotion shall not encourage clients to trade in a manner inconsistent with their trading comfort level. Clients should seek independent advice if necessary.
