



SPECIFIC PROMOTION TERMS AND CONDITIONS

FOR TITAN FX WINTER GIVEAWAY PROMOTION

Titan FX Winter Giveaway promotion (the **Promotion**) is provided by Titan FX Limited, Titan Markets, Goliath Trading Limited and Atlantic Markets Limited, trading under Titan FX (Titan FX) to their clients. By participating in this Promotion, the clients hereby acknowledge, confirm and accept to be bound by the following terms and by [Titan FX's Terms and Conditions](#).

Promotion Overview

This Promotion offers eligible clients the chance to win a prize during the Promotion Period from **December 22nd, 2025, 00:00 GMT+2 to January 18th, 2026, 23:59 GMT+2** (the "**Promotion Period**').

1. Specific Offer terms

- 1.1. The client must register for the Promotion in their Client Cabinet and select their Promotion account. Registrations for the Promotion will open during the Promotion Period as defined above.
- 1.2. Clients must meet the requirements in the table below to participate in the prize draws. (Tier Draws 1-4 and Points Club Giveaway Draw)

- 1.3. Two hundred and one (201) winners will be randomly chosen from all eligible participants at the end of the Promotion Period and will be announced on the Titan FX website no later than 23rd January 2025.
- 1.4. Prize draws are carried out in the following order:
 - 1.4.1. **Tier 1 Draw:** winners are randomly chosen from all traders who qualify for Tier 1;
 - 1.4.2. **Tier 2 Draw:** winners are randomly chosen from all traders who qualify for Tier 2, as well as any Tier 1 traders who didn't win a prize in the Tier 1 draw;
 - 1.4.3. **Tier 3 Draw:** winners are randomly chosen from all traders who qualify for Tier 3, along with any the traders from Tier 2 and Tier 1 who didn't win a prize in the previous draws;
 - 1.4.4. **Tier 4 Draw:** winners are randomly chosen from all traders who qualify for Tier 4, plus any traders from Tiers 1,2 and 3 who didn't win a prize in the the previous draws;
 - 1.4.5. **Points Club Giveaway Draw:** winners are randomly chosen from all traders who qualify for Points Club Giveaway, regardless of whether they have already won a prize in any of the Tier1-Tier 4 draws.

- 1.5. Each client is eligible to win a maximum of two prizes - one prize from the Tier Draws (Tiers 1-4: Clauses 1.4.1. -1.4.4.) and one from the Points Club Giveaway draw.
- 1.6. Winners will be notified within three (3) working days of the winner announcement via the client's provided email.

2. Net deposit requirements:

- 2.1. The client's net deposits are the sum of all deposits minus all withdrawals in all their accounts between registering for the Promotion and at the end of the Promotion Period.
- 2.2. Net deposits are calculated in the currency of the client's chosen main Promotion account. If the client makes deposits or withdrawals into/from other accounts that have a different account currency, the current exchange rate is used to convert the deposit or withdrawal into the Promotion account currency.
- 2.3. Withdrawals of only trading profit earned during the current week of the Promotion will not be subtracted from the net deposits.
- 2.4. If the client withdraws more than their trading profit or a portion or all of their deposited amount at any time during the Promotion Period, this may decrease their net deposit amount which may result in them being ineligible to win prizes.

3. Trade value requirements:

- 3.1. Trade value is the total notional trade value of all the trades in any of the client's accounts, that were opened after the client registered for the Promotion until the end of the Promotion Period. For reference, 1 lot of EURUSD is valued at 100,000 USD.
- 3.2. All asset classes, including those traded in micro accounts, are eligible and count towards the total trade value.

- 3.3. Trade value is recorded at the time that the trade is opened.
- 3.4. Only trades that are open for more than two (2) minutes are eligible trades.

4. Prize details

- 4.1. If delivery of a non-cash prize is unavailable in your area, an equivalent amount of the prize value will be credited to your Titan FX trading account.
- 4.2. The client must choose an address of delivery for the prize. The address must be on the name of the client.
- 4.3. It is the client's responsibility to ensure that an accurate delivery address is provided. The client cannot change the delivery address once the prize has been claimed.
- 4.4. The prize is handed to the client at the address of delivery by courier. If the client is absent for delivery, the courier will handle the re-delivery. The client shall contact the courier to ensure delivery.
- 4.5. The cash prize (if selected) is presented as a transfer into the client's Titan FX live trading account selected as the main Promotion account when registering. If the main Promotion account is not a USD or JPY account, the current exchange rate is used to convert the cash prize amount into the Promotion account currency.
- 4.6. It is the client's responsibility to ensure that accurate and up-to-date contact details are provided. If Titan FX is unable to contact the client due to inaccurate contact details provided, and the client does not contact Titan FX within thirty (30) days to claim their prize, the client's prize will be forfeited. Titan FX shall bear no liability for any unclaimed or voided prizes.
- 4.7. The prize cannot be exchanged. In the event that the prize offered is unavailable due to circumstances beyond the control of Titan FX, Titan FX reserves the right to provide an alternative prize.

- 4.8. Titan FX does not provide invoices and warranty certificates for electronics.
- 4.9. If the client receives a damaged or broken prize, the client must send a photo or video to the customer support of Titan FX. If the damage is confirmed, Titan FX will replace the prize.
- 4.10. Images used in marketing materials and on the website of Titan FX are for illustration purposes only and are not representative of actual prizes.

5. Trade and account eligibility

- 5.1. This Promotion is applicable to all live Titan FX accounts (Standard, Blade, Micro).
- 5.2. Clients must have a registered and verified account with Titan FX.
- 5.3. Both new and existing clients are eligible to participate.
- 5.4. This Promotion is applicable to all instruments.

6. Fraudulent activity

- 6.1. Titan FX at its sole discretion can exclude a client from participating in this Promotion:
 - 6.1.1. if a client is suspected of fraudulent activity; and/or
 - 6.1.2. and/or a client has not acted in good faith; and/or
 - 6.1.3. and/or an action by a client is found to be in violation of these terms or Titan FX's Terms and Conditions ; and/or
 - 6.1.4. if a client submits false ID documents and phone number for the verification procedure.
- 6.2. Titan FX reserves the right to withhold, void or reverse any cashback amounts (including those which have already been credited or paid), or/and restrict or terminate the client's trading account, without further notice if in its reasonable belief, there is any indication or suspicion of any form of arbitrage (including but not limited to risk free profiting), abuse, fraud,

manipulation, cash-back arbitrage connected to a trading bonus or any other form(s) of deceitful or fraudulent activity or behaviour (artificial trading activity, false identity or misrepresentation, collusion or coordinated trading, multiple accounts registrations under the same individual or associated parties to gain an unfair advantage).

- 6.3. Furthermore, Titan FX reserves the right to cancel, void, reverse or adjust any profit or/and loss, and to recover or claw back any funds, resulting directly or indirectly from any fraudulent, abusive, deceitful or manipulative trading activity as described above.

7. General conditions and warranties

- 7.1. In participating in this Promotion, the client agrees to be bound by these terms and Titan FX's Terms and Conditions.
- 7.2. The client agrees that Titan FX has the right to alter, update or cancel this Promotion at any time without any prior notice or justification to the client.
- 7.3. The client agrees that Titan FX will not be held responsible for any consequences resulting from any alteration, update or cancellation of this Promotion.
- 7.4. The Client agrees that Titan FX shall not be held responsible for any technical disruption, such as weak internet connection, that could affect the result of the Promotion.
- 7.5. Titan FX reserves the right to refuse offering this Promotion at its sole discretion without prior notification or justification.
- 7.6. Titan FX will not be liable for any adverse effects where an account has open positions or floating profit/loss which results in the Promotion being removed for any reason.

- 7.7. New accounts are subject to approval as per Titan FX's Terms and Conditions. This Promotion is not an offer to any person to whom it would not be lawful.
- 7.8. This Promotion shall not encourage clients to trade in a manner inconsistent with their trading comfort level. Clients should seek independent advice if necessary.
- 7.9. By participating in this Promotion, you consent to your personal data being collected, processed, and used by Titan FX for marketing and promotional purposes.
- 7.10. Titan FX will not be liable for any loss, costs, expense or damage suffered in connection with this Promotion.
- 7.11. Any dispute will be resolved by Titan FX in a fair manner.
- 7.12. If these terms are translated in another language other than English, the English version of these terms is the official version and shall prevail in case of inconsistency.
